**APPROVAL OF MINUTES**

- Minutes for the August meeting were approved as submitted.

**TREASURER'S REPORT**

- The Treasurer's Report stated there were no expenses or withdrawals and was approved as submitted.
- A purchase of \$28.00 was made for candy for the supervisor's Lancaster office and was submitted.

**COMMUNICATIONS**

- General reporting about the Station fire from community members was given, with more detailed information in the Reports section.
- Generally, community members are having great difficulty getting current accurate information about the fire and sheriff evacuations.

**ITEMS OF INTEREST**

- **Devils Punchbowl County Park** - Full moon hike cancelled due to Station fire.

**GOVERNMENT REPRESENTATIVES' ANNOUNCEMENT**

- **Mr. Norm Hickling, Supervisor's Office was not in attendance. He was attending a Town Hall meeting in Wrightwood regarding the Station Fire.**

**LA CO Sheriff's –**

- **Dep. Ferrell:** The suspect in the cockfighting ring was convicted. There is a search and seizure on property so they confiscated all of the chickens and can do searches at any time.
- **Forest Rave Parties:** There have been parties reported in Lancaster, Sorenson Park in Lake Los Angeles, and in the forest area around Lake Hughes area.

## **REPORTS**

### **STATION FIRE UPDATE:**

- 1. UP-TO-DATE AND ACCURATE INFORMATION CONCERNING THE STATION FIRE HAS NOT BEEN OCCURRING, AND IS CRUCIAL FOR JUNIPER HILLS RESIDENTS.**
2. The Town Council needs to request a Public Information Officer for our area.
3. Trap line Information Officer has a board in a central location in other communities.
4. Trouble with dissemination from the LA County Sheriff's office regarding evacuation Procedures. There has been much confusion as to whether the evacuations have been voluntary or mandatory.
5. The reverse 911 calls did not work according to the supervisor's office and community members and it needs to be fixed.
6. The stoppage of Bulldozers in the Juniper Hills area because of the Pleasant View Wilderness area and the Arroyo Toad needs to be remedied immediately for adequate Fire breaks.
7. The LA County Sheriff's department needs to be consistent as for determining voluntary evacuation versus mandatory and be vigilant in protection of homes and property once the mandatory evacuation notice has been given. So far, the notice has changed quickly with times that no police presence is noted with high chance of looting occurring.

### **Additional reporting:**

- Deputy Ferrell discussed assignment of deputies on watch during fire incident.
- Vance Pomeroy gave a report from the Acton meeting about the Station Fire on Tuesday, Sept. 1, 2009, and had discussion with Chief Bryant about wilderness and fire protection using whatever means are necessary.

## **LIGHTING**

- A letter was received by e-mail from Mr. David Stringer that stated that Street Lights removal of a shield on 96<sup>th</sup> St. East and Cima Mesa was recommended by Mr. Stringer. It also asked if the JHTC wanted removal of an existing shield on 106<sup>th</sup> St. East and Fort Tejon. The JHTC had a discussion about the light at Cima and Fort Tejon. A recommendation by Mr. Pomeroy to have Mr. Stringer and a Road Engineer go to the site and have a field trip/meeting with town council. The town council will recommend leaving the light alone in the meantime. David Reichel is to write a letter to Mr. Stringer to state the wishes of the JHTC.

## **NEW BUSINESS**

- Suzanne provided information on the new Juniper Hills sweatshirts that are being planned. Motion by Suzanne to ay for a sweatshirt sample. The motion was seconded and passed. The town council must decide if a new image will be placed on the sweatshirts. Motion by Suzanne to pay a deposit of \$500.00 to a T-shirt company. The motion was seconded by David. The motion was withdrawn by Suzanne.
